Thirty-five years ago, a small group of Malden-area citizens created The Community Family to provide community-based care and to support individuals and families seeking to avoid nursing home care. As our name implies, The Community Family (TCF) aspired to become a community-based extension of family. Comments such as the one on the opposite page from a grateful family member, illustrate that for those we serve, TCF has become part of many extended families.

Over the years, The Community Family has evolved while maintaining its core values of compassion, service, excellence, family support, and community involvement. TCF grew from a start-up with a \$20,000 grant and borrowed space to an established organization with three beautiful centers and 65 dedicated, highly skilled staff.

Early on, TCF recognized the need to create specialized programs for those with Alzheimer's disease. In 1981, TCF opened its Medford Center – the first Alzheimer's adult day health program in the state. Today two of TCF's centers, Medford and Lowell, are the only Alzheimer's specific programs in their geographic areas. TCF is widely recognized as an expert in Alzheimer's care. The Everett center, TCF's largest center, provides a wide array of services to a very diverse group who have chronic medical and/or psychological conditions.

Our clients and their families share a deep desire to live in the comfort of their homes as long as possible. To this end, TCF steadfastly provides *care ... above and beyond*. TCF's growth has included increased sophistication of medical services, robust activity programming to appeal to diverse interests, and our construction of three modern centers where those we serve receive dignified care in beautiful and spacious surroundings.

This has been an busy year – as we prepare for new state licensing standards while simultaneously creating new materials and other vehicles that show the value of our services. We believe that our services will play a pivotal role in the changing landscape of health-care delivery. To this end, we are establishing new relationships with other community health partners such as the North Shore Elder Service Plan, the One Care program and the Acquired Brain Injury program. Our efforts are guided by the goals, objectives and work plans set forth in our strategic plan developed last year and updated quarterly.

No review of our accomplishments would be complete without thanking our exceptional Board of Directors, management team and staff who daily demonstrate a firm commitment to our mission and clients. We are confident that TCF will face future challenges well grounded in its mission with continued resolve to maintain our tradition of *care ... above and beyond* for all who need our services. TCF's compassionate staff ensure that each day is filled with love, laughter and a sense of belonging. In the words of a pleased family member:

### TCF by the Numbers: Statistical Profile of Services Provided in 2013


### **TCF Services Provided in 2013**

- Provided 34,500 days of care to 365 frail elders, those with Alzheimer's, and adults with disabilities.
- TCF vans provided 23,000 transportation round-trips from our clients' homes to our centers.
- TCF provided more than \$4 million in savings to the state over the cost of nursing home care, if only 20% of those we served were forced to enter a nursing home to receive the care they require for the year of 2013.
- Of our 65 employees, fully 57% of them have 5+ years of dedicated service to TCF, with an impressive 34% having 10+ years of service.
- This year TCF provided care to 3 couples, 4 sets of parents and children, and the second generation of a former client - both who had Alzheimer's.

### **Other Notable 2013 Highlights:**

- Gerald Sohn, founding Board member, received the Excellence in Governance Award from LeadingAge Massachusetts for his 35 years of stewardship at The Community Family.
- TCF's first "care ... above and beyond Employee Recognition Award" was given to three employees. See story on page 3 (right).
- TCF redesigned its outreach material and commissioned a promotional film to highlight the benefits of our services.
- The Community Family was awarded a \$100,000 multi-year grant from the Cummings Foundation as part of their "100K for 100" program.

### Improving Quality of Life for both Clients and their Families



- TCF contracts with music therapists, art therapists, exercise consultants and entertainers to add meaning and enjoyment to daily programming.
- Each center now has an interactive computer system designed for older adults, offering a wide range of music, travel, games, and entertainment options.
- Alzheimer's Caregiver Support Groups are offered at the Medford and Lowell centers. The Medford group, facilitated by board member Doug Lloyd, is the longest continually running support group in the state.
- Medical services provided include management of chronic physical and psychological conditions, treatments, medication management, and care coordination.

Employees from all three centers submitted ideas encompassing the notions of compassion, service, family and fun. ## The Community Family: A Financial Profile for 2013

The Community Family (TCF) is well positioned to continue to provide high quality adult day health services today and into the future. The Everett Center accounts for 44% of services delivered in 2013. As was the case in 2012, the Medford and Lowell centers had lower than projected census and revenue. The largest portion of TCF's revenue was generated through Medicaid, which represented 58% of all revenue, demonstrating that TCF primarily serves adults of very modest means. The Everett Center provides care at the basic and complex levels of care while the Medford and Lowell centers provide care at the complex level, due to their Alzheimer's focus. More than half – 64% – of expenses are related to personnel needed to operate TCF's programs.
